QUISSETT COLLECTION - HISTORY

The area known as Quissett is halfway (2 miles each way) from Woods Hole and Falmouth. Historically it was a distinct village, with its own post office and general store located near the four-corner crossroads from the County Road (Woods Hole Road or Route 28) to Quissett Harbor. The Harbor has been a central focus of the area. It is a well-protected harbor which leads to Buzzards Bay.

The village did not have its own church or town organization but did have its own Hall for social purposes. The area had a very strong identity as a distinct location, separate from Falmouth and Woods Hole.

Quissett was settled in the early 1700s by the Weeks family and the Rowley, Jenkins and Gifford families. By the first (1790) census there were 10 heads of family at Quissett for the Eldridge (Eldred), Nye, two Rowley families, Hammond, Chadwick and three Davis families.

The Eldred homestead overlooked the harbor from the north. The Hammond, Jenkins, Gifford and Rowley properties were on the Bay side of the harbor. The Fish family property was on the east side of the harbor.

In 1802 a stone dock was constructed on the eastern side of the inner harbor below the home of Barney Marchant who owned the land south of Thomas Fish. A small shipyard began at this dock with Thomas Fish as shipwright and his neighbors as partners and shareholders in the trade that resulted from the Quissett-built vessels: the brig *Victory*, the brig *Enterprise*, the bark *Union* and the sloop *Susannah*. Partners Isaiah Hammond, Zephaniah Robinson and Barney Marchant engaged in coastal and West Indian trade.

Thomas Fish became a prominent citizen in Quissett. He was a deacon in the Falmouth Congregational Church (and always honored with the title of "deacon"), a justice of the peace and a representative in the state legislature.

During the War of 1812 great care was taken to hide the presence of a harbor and its vessels from the British warships coming into Buzzards Bay. In Quissett Harbor ships were camouflaged with foliage and some boats had treetops lashed to their masts to disguise the very existence of a body of water.

After the Civil War, men who had served as officers in the war returned to Quissett and brought their friends as well. Col. James M. Lewis, a physician and grandson of Deacon Thomas Fish, returned from the mid-west where he had served in the 28th Regiment of Wisconsin. James Milton Lewis was born in Falmouth. He was the son of David Lewis, Jr. and Cynthia Fish Lewis (daughter of Deacon Thomas Fish). He married Jane W. Andrew in Falmouth in 1849.

By the early 1870s, he was a business associate of Col. Abraham H. Ryan in Little Rock, Arkansas. Ryan began to invest in Quissett land in the 1870s. In 1871it was recorded that Mrs. Jane W. Lewis of Little Rock, Arkansas purchased the Jenkins house and forty-seven acres on the west side of Quissett Harbor from Susannah Fish Jenkins for \$2100. In other words, Mrs. Lewis purchased the land and house from her husband's aunt, as Susannah Fish Jenkins was also the daughter of Deacon Thomas Fish. In 1872, Mrs. Lewis also purchased the adjacent Hammond-Chadwick house (then owned by Braddock Gifford and Samuel H. Chadwick). The purchase of the Chadwick house also included rights to a well on the property and "cranberry land" of Gifford's.

The Lewises appear to have been the builders of the Victorian Gothic cottage which was originally positioned to the north of the Jenkins and Chadwick houses (and which was later moved to the south end of the hotel complex by Stephen W. Carey). They also made up a plan for land development in Quissett with forty lots on it. At some point in the 1870's, Col. Lewis had the two

houses (Hammond-Chadwick and Jenkins houses) run for him as a hotel. We have a letter to Thomas Dunham Fish from a Mr. Whitbeck in 1877 with "Quissette Harbor House" on the letterhead and Whitbeck listed as "proprietor". The connector between the houses was built at an unknown date. Stephen W. Carey bought the Quissett Harbor House from Jane Lewis in 1881 for \$9,675.

By the 1880s the Harbor House was managed by George W. Fish, another grandson of Deacon Thomas Fish. He too listed himself for his entire tenure as "proprietor" and ran the hotel until 1917.

The Stephen W. Carey family had come to Quissett through marriage relationships. Stephen Carey had married Sarah Smith Boardman Yale. Her sister Albinia Yale married Thomas Dunham Fish of Quissett (grandson of Deacon Thomas Fish). When Albinia died after giving birth to a daughter, the child, Maria, was brought up by Sarah Yale in Montclair, New Jersey. Both Stephen W. Carey and Thomas D. Fish were commission merchants, freight brokers and ship owners in New York and lived in New Jersey. Eventually the Careys came to spend summers at the Fish "Homestead" and later built their own home on the opposite side of the harbor.

Since George W. Fish did not open the Harbor House for 1917, a Carey descendent, Lewis W. Francis of New York, came to open the hotel that year as a "family boarding house in a small way". His manager was Walter Scott. Later Francis persuaded Stephen W. Carey Jr. to take over the hotel. Stephen W. Carey Jr.'s daughter Cornelia Lee Carey ran it until her death in 1973. The Harbor House was a center of summer activity at Quissett Harbor for about 100 years. Very old-fashioned, some of it without running water, it was a much beloved establishment. The hotel consisted of the Hammond house, joined to the Jenkins house by a connector, with a large dining hall behind the Jenkins house. A long single-story extension to the south of the bigger buildings was known as the "Bowling Alley". At the very south end of the complex was "The Cottage", the original Lewis Gothic-style cottage.

The Jenkins house and the dining hall for the hotel still exist; the Hammond house was flaked and moved to the northwestern U.S. to be re-erected. The hotel complex was acquired in 1977 by the newly formed Quissett Harbor House Land Trust, Inc. and most of the owners of property around the harbor and area joined the Trust. The Trust and Salt Pond run the two adjacent areas for the benefit of the members and the public.

In the 1990s the Bowling Alley and The Cottage were burned. A low extension and a small building replicating the shape of the originals are used by the Quissett Yacht Club sailing school and as a caretaker's cottage.

Quissett harbor has become an crowded sailing center and the focus of an active yacht club, founded in 1912. It has one of the largest fleets of Herreshoff 12 ½ sail boats in the area. However the Quissett Yacht Club does not have a clubhouse.

The Quissett Harbor boatyard, begun by Charles L. Eldred and Joseph Fish, Jr. around 1890, passed on to Charles L. Eldred, Jr. and then to Bruce Barnard in 1958. At this time it is owned and operated by Bruce's daughter Weatherly (Barnard) Dorris and her husband Rick Dorris.

Conservation land known as "The Knob", which was given by Cornelia Carey to the Salt Pond Areas Bird Sanctuaries, Inc., is a popular walking place as well as a beach area that faces Buzzards Bay.

With the erection of a house by Col. Ryan at the more southern part of the east side of Quissett Harbor in 1885, a group of large summer "cottages" were built by related families and others towards Woods Hole along the Harbor which prompted the construction of Quissett Avenue in the 1880s. These included the Marshall estate (now the National Academy of Science), "Red Oaks" and the famous Webster estate with its magnificent rose garden (demolished in 1970). Other large summer homes were built on the ridge north of the Quissett cross-roads along County Road (Route 28) from the 1870s to the early 1900s. All of these areas have become known as part of Quissett.

Quissett no longer has its own post office or store. A traffic light on Route 28 gives an indication of this formerly important cross-roads. Quissett, it has been said, is a state of mind.

QUISSETT COLLECTION - SCOPE

The Quissett Collection includes photographs, deeds, ledger-books from the Quissett Harbor House; records, ledgers and material on Quissett Hall and the Quissett Social Club; ephemera and letters, personal reminiscences of the area, genealogy, property and house histories. An adjunct collection is the large Fish-Morse Collection which contains considerable material on the Fish family and Morse family, as well as the Carey and Yale families.
