BIOGRAPHICAL NOTE

George Cottle Look 1867-1938

George Cottle Look was born in Tisbury, Martha's Vineyard, Massachusetts, May 4, 1867. He married (1) Anna Phillips of Harwich in 1889. and married (2) her sister Lillian in 1933. In Woods Hole he owned two houses on Buzzards Bay Avenue. His business in Woods Hole was the Woods Hole Market, located at the corner of Depot (later Railroad) Avenue and Water (Main) Street. Mr. Look died December 10, 1938 in Woods Hole.

SCOPE NOTE

The Woods Hole Market and George C. Look Collection contains business letters and business ephemera from the grocery business run by George C. Look during the early years of the 20th century. The business letterheads and ephemera of the period are wonderful examples of early 20th century graphic design. Mr. Look was also the Postmaster of Woods Hole from 1905 and following re-appointment in 1909.

George C. Look's daughter Elizabeth married Charles Morse. For related family information, see Morse Collection in the W.H.H.C. Archives. The Morse Collection contains 19th century and early 20th century photographs that include the Look family.
